Call to Order

Meeting was called to order by Sharon Shivers, President at 2:10 PM

Meeting Minutes

Approval of October minutes with September 1-30 financial report. Motion made by Howland Bailey and second by Sam Schaller.

President's Report

- FFMIA Conference Recap
 - There is a new study coming out from the University of Miami focusing on cancer in fire inspectors and fire investigators.
 - If you are interested, please let me know and I can send you some information.
 - Our monthly meeting can count towards the required training hours needed for ISO.

- Our monthly meeting minutes/sign-in sheet can be used to validate the time.
- The information on classes for the NFPA 1 and NFPA 101 changes.
 - Moving forward with future code cycles they would like to provide at least six months' advance notice for upcoming changes.
 - Rulemaking for proposed changes to the next code cycle is already underway.
- There was some talk about trying to form a task group among AHJs and DBPR on how to get a better handle on mobile food vendors.
 - Currently there are no guidelines/regulations for the construction of them. You
 essentially can build it in your backyard.
 - DBPR as we know is very hands off, putting a lot more on us.
 - There is some push to try and put a little more onto DBPR.
- LP-gas pipe inspection was removed from the code.
 - It now would have to be cited under Chapter 1 for 3rd party inspections required.
 - Seminole County is keeping the requirement and citing accordingly.
 - We as a group need to decide if we want to continue enforcing it.
- Batteries
 - Sam Schaller advised the group that Zinc batteries are gaining popularity in the data center and hospital settings.
 - They are plastic and self-suppressing and meant to be used as a backup for power until the generator kicks on.
 - They are proving to be more costly than lithium-ion batteries, but cheaper to maintain.
 - Lisa Nadeau mentioned that FFMIA is interested in collecting/tracking data related to lithium battery fires.
- FFMIA Central Florida Regional Director
 - Christina Diaz with the Seminole County Fire Department is our new regional director for our area.
 - We communicated with that that we would like to work together more, and that communication is lacking.
 - We are also interested in more local classes since those also have been lacking in our area.
- Upcoming Chiefs' Group Meeting
 - I will be bringing up the food truck MOG which needs to be revised due to the new code cycle.
 - I will be bringing up interest shown with fire inspectors from other jurisdictions crossing over to help assist with food truck inspections/evaluations during large scale events.

- Red Book
 - There is strong interest in developing a county-wide red book like Orange County's.
 - We would include an appendix(es) for each municipality/jurisdiction on specific changes (i.e. turning radius, hydrant placement, a common book.
 - Chief Allen was going to push out the Orange County Red Book for the Chiefs to look over, so will follow up on that.

Vice-President's Report

- o Jewelry/Pawn Shops
 - How does everyone handle the 20lb cylinders and LP-gas torches? Do you require them to comply with NFPA 58?
 - The consensus of the group seemed to not be overly concerned with their use if it is minimal and not storing in excess quantities.

Chip Johnson

- o BDA Grid Testing
 - Currently working on BDAs at Deltona High School, Pine Ridge High School and University High School.
 - Fred Link advised them to be cautious with the contractors they use. While they can
 install the BDA. They may not be licensed to connect it to the fire alarm which would
 require a fire alarm permit and contractor.
 - Chip advised they are continuing to move forward with the BDAs where required and not waiting on the P25 upgrade.
 - All new construction gets the infrastructure put into place just as a precaution should one ever be needed down the road.

New Business

Tom Smith

- *◦* Hydrants
 - ISO requires a two-hydrant flow test, but NFPA 25 only requires one hydrant flow. Would like some clarity on what each jurisdiction requires.
 - NFPA 25 requires that hydrants be opened, and water run clear for a minimum of one minute and flow tests required every five years. Would like some clarity on what each jurisdiction requires.
 - Color coding fire hydrants based on flow, to include what color each jurisdiction wants to identify private and public hydrants.
- o 3rd Party ITM Reporting
 - Needs to know what jurisdictions require this since there is a cost factor associated. Also believes the Red Book would provide clarity on this.
